NEW BUSINESS:

Joan Bender said the invocation Prayer.

1. 2. SWEAR IN NEW COUNCIL MEMBERS THAT WERE ELECTED IN NOVEMBER.

Anderson and Cada were congratulated for winning the election and welcomed to the Council by Mayor Brown.

3. APPROVAL TO CHANGE BANKS.

Mayor Brown said the U.S. Bank is closing on January 27, 2022. Brown said he would like to keep banking local and would like permission from the Council to change the bank to the Latah Credit Union.

Marty Anderson made a motion to change banking to Latah Credit Union. The motion was seconded by Dave Cada, the motion was approved with "all ayes".

4. APPROVAL TO PURCHASE REPLACEMENT FOR GATOR.

Mayor Brown said he and Marty Anderson went and looked for a replacement for the Gator and would like to purchase a Kubota which is a diesel model with cab and blade the price would be \$25,000 to \$30,000. We could purchase a cab for the gator for around \$6,000 and it also needs need tires.

Joan Bender made a motion to approve the purchase of a Kubota UTV to replace the gator and cab and tires for the gator. Donna Winther seconded the motion, the motion was approved with "all ayes".

5. APPROVAL TO SIGN IDAHO DEPARTMENT OF ENVIRONMENTAL QUALITY (DEQ) LETTER OF INTEREST FOR DRINKING WATER PLANNING GRANT.

Mayor Brown asked for approval to sign the Idaho Department of Environmental Quality Letter of Interest for the Water Planning Grant.



Mayor Brown said that there will be money out there for this type of grant in the future so the city needs to be ready. This is a letter that lets DEQ know that the city is interested in applying for the grant. Once the DEQ letter of interest is approval then the city will apply for the grant.

Joan Bender made a motion to approve signing the Idaho Department of Environmental Quality Letter of Interest for the Drinking Water Planning Grant. The motion was seconded by Donna Winther, the motion was approved with "all ayes".


6. APPROVE AND SIGN AUDIT LETTER FOR SEPTEMBER 2020 AUDIT.

- 3. **Pool & Cemetery Donna Winther –** Donna said that she looked at the floor at the Pool bathhouse and talked with sales rep. about the floor. She said she will continue to do some research.




- 4. Water & Sewer Dave Cada Nothing at this time.

3. OLD LIONS CLUB BUILDING RENTAL.

Mayor Brown said that Hailey Nagle was interested in renting the building so she could have her hair and eyelash salon. He said there was some interest in renting or would the Council be interested in selling the building. Council said at this time they wouldn't be interested in selling but would like it to be rented to Hailey. Hailey asked a few months ago if she could rent the 2nd floor of the building when it was Gypsy Mountain. 4. CHANGE ORDINANCE FOR VENDOR APPLICATIONS AND JAKE BRAKES.

5. PURCHASE ELECTRONIC WATER METERS.

Mayor Brown asked if Council would approve purchasing the electronic water meters for the rest of the town. He said there is more grant money out there that would be for water and sewer infrastructure. The City Maintenance workers will be replacing the 20 water meters that have been purchase so far in Bennett's Addition. Council discussed several other areas that the meters could be replaced. Mayor Brown said that the previous quote for water meters has increase so not would be the time to purchase more. Council agreed to wait to purchase until we know for sure if there is grant money out there. Mayor Brown said he would check with CEDA to see if they have heard of grant money available.

6. APPROVE TRANSPORTATION PLAN AGREEMENT.

Mayor Brown said that he had talked with Tom Moore about the Transportation Plan and Tom said with the other water and sewer projects going on that he didn't think he would have the time to do the Transportation Plan. Mayor Brown said that he talked with Angela Taylor at Keller & Associates and she said that they are working with several small Cities and they could do the Transportation Plan. The City received a grant for \$50,000 to complete the Transportation Plan. He said he would like to get Council's approval to sign the agreement with Keller & Associates.

Dave Cada made a motion to approve hiring Keller & Associates to complete the Transportation Plan. The motion was seconded by Joan Bender, the motion was approved with "all ayes".

- 1. **Mayor David Brown –** Mayor Brown handed out a quote that he received for the bathroom at the Scenic 6 Park from CTX. This would be for a premade building that would include plumbing and electrical. Council talked about different options that would work at the park for a bathroom but agreed that the price was too high. Mayor Brown said that the Kubota is ordered and the final price was \$25,748.05. It will be about 6 months before we receive it. It has a cab and a blade included in the price. He also talked with John Deere about a cab for the gator but the price was \$8,800.00. Mayor Brown talked about the CEDA survey for Latah County that needs to be turned in 1/31/22. Council briefly talked about the different project and decided to meet later in the week to go over the list. Judi will contact everyone to get a meeting set up.
- 2. **Parks Joan Bender –** Joan said that Karin will be moving in soon to be the camp host hopefully in February.

- 4. **Pool & Cemetery Donna Winther –** Donna said that she contact another company out of Post Falls to take a look at the flooring at the pool and give her a quote. The company is called Croc's Coating and what they suggested would be layered flooring. Donna explained what the layers were and how it would be installed. She also went over some other products that might work and said if anyone would like to meet on Monday at 10:30 to talk with the Vendor. Mayor Brown said that the sinks and stools also need to be replaced and the urinal taken out.
- 5. **Water & Sewer Dave Cada –** Dave Cada said that he would talk about the aquifer report at the next meeting.



- 6. **Streets Martin Anderson -** Marty asked if the city was doing any paving this year and Mayor Brown said not at this time. Mary asked if we would be purchasing the pot hole mix again this year.
- 7. **Scenic 6 David Cada** Dave said that the Scenic 6 group met last Wednesday but attendance was not good.
- 8. **Clerk Judi Davis –** Judi said she turned in her two week notice to the Mayor effective 2/4/22. Mayor Brown asked Council if they would like to advertise for the Clerk/Treasurer position. Council agreed to advertise.


PUBLIC COMMENT:



3. SCOTT LINJA, KELLER ENGINEERING, TRANSPORTATION PLAN

Scott Linja will be working with the city to form a Citizen Advisory Committee comprised of citizens, business owners, emergency services, representatives from City Hall and the School District. The committee will gather to provide comments to steer the transportation plan in the right direction. He would like the group to meet in March to schedule meeting times and create a time-line. He would like to have 3-4 meetings with the Citizen Advisory Committee and gain public input to have the plan completed by November. The transportation plan will provide the city with a Capital Improvement Plan, projects that the city would like done in the next 5-10 years. A Capital Improvement Plan will get the city more points when applying for an LHAPC grant. Mayor Brown asked if the transportation plan fits in the comp plan CEDA helped the city with years ago. Scott said, yes, the plans work together. Martin Anderson asked how long the plan is good for. Scott said the plan would need to be revised and updated every 5 years but the plan would last at least 10 years and up to 20 years. Scott will follow up with the city to get contacts lined up for the committee and set up the first meetings.

4. POE ASPHALT PAVING QUOTE

Mayor Brown introduced the POE Asphalt paving quote for \$28,695 and said the \$9,135.76 from the LHTAC grant could be used to help pay for this paving. The proposed plan is to pave approximately 250ft on Spruce Street from Highway 6 to Ponderosa. David Cada asked if this was the only paving being done this year. Mayor Brown said Cedar Street is in need of improvement. Martin Anderson asked if the city had the money could it all be done at one time. Mayor Brown agreed that would be good and will ask



Scott Williams from POE for a quote to include Cedar Street from Highway 6 to Seventh Street.

Martin Anderson made a motion to approve the POE paving project, David Cada seconded the motion, the motion was approved with "all ayes".


REPORTS:

1. **Mayor - David Brown -** Mayor Brown said BJ Swanson called about the block building behind Rebekah Hall that is owned by the senior center. The



building needs a new roof or to be torn down. Currently the lot is separated but the county can put it back to one lot and it could be sold as such or used for parking. David Cada asked if there was anything in the building. Martin Anderson said he didn't think there was anything of value in there and asked about the old stick building by the VFW if it could be torn down and the lot used for parking as there is a need for parking in the city.

- 2. Parks Joan Bender Joan said she went with Donna Winther and David Cada to meet with Croc Coatings from Post Falls regarding coatings for the pool and fixing the bathrooms and showers at the RV Park. Mayor Brown said Blue Cross of Idaho has a deal where they will pick 5 communities in the state every year and give up to \$85,000 to help build a pavilion. Mayor Brown has sent in the paperwork to apply for this. Mayor Brown would also like a bench in honor of his late wife, Grace, to be placed by Harvey's Pond and also a cement slab in honor of his late brother who donated a TV and other things to City Hall. Donna Winther asked if the Transportation Plan could help get better access, like a path, to the pond and Scenic 6 Park from the Depot. Mayor Brown said the land belongs to the railroad and we would need to find out what rights the city has to the land.
- 3. **Pool & Cemetery Donna Winther -** Donna said she, David Cada and Joan Bender met with Croc Coatings from Post Falls regarding coatings for the pool and fixing the bathrooms and showers at the RV Park. She said they had a very good product, similar to Skeltons. Donna handed out the quote from Croc Coatings. David Cada said the sample from Croc's was good and the product looked like it could last a long time. Donna Winther asked if there was a possibility of getting a new pool. Mayor Brown said the State has money for pools right now and that would be worth looking into. Donna Winther said something needs to be done at the pool before it opens. Mayor Brown said a clear coat over the cement at the pool could be more cost effective and would work for this year. Joan Bender said the bathrooms at the RV Park are fine but the showers need work. Donna Winther said we could have Croc's do just the showers at the RV Park. Mayor Brown said the RV Park has untaxed money that can be put toward the shower repair and asked that Donna get a quote from Skeltons for the work and find out their warranty. Martin Anderson said the warranty for Croc's is 5 years for a commercial building.




Joan Bender said to go with the most cost effective and asked how much a new pool building would cost. Mayor Brown said this should be looked into before spending money on new flooring and we should see what the rec. district could contribute. Martin Anderson said for sure so the showers at the RV Park need to be done and all agreed. Donna Winther will get a bid from Skeltons for the showers and a vote will take place at the next council meeting.

- 4. Water & Sewer David Cada David Cada gave a fascinating report on the Grand Ronde basalt and Onaway volcanics, large cracks formed 17million years ago where Potlatch gets its water. In regards to the new housing development David Cada said there is plenty of water. At the next council meeting David will report on where the water comes from and how it recharges. Mayor Brown said Wayne Gallagher and partner will be here in a few weeks with the plans for the new development. They will hire out the work to Hodge and Associates. Martin Anderson asked if the city needed an engineer to be on site to make sure the well is drilled to city's specifications. Mayor Brown said it needed to be done to DEQ specifications. Joan Bender asked if the street plans were ready for the development. Mayor Brown said they were planning on 50 homes on the 19 acres and Ziply will put in fiber for free.
- 5. **Streets Martin Anderson -** Martin had nothing more to add regarding streets as paving was already covered.
- 6. **Scenic 6 David Cada** David said that Shan Hemphill and Mike Hoskins had some good ideas.
- 7. **Clerk Harmony Nowack –** Harmony thanked the council for the appointment and said she has calls out to Latah County Credit Union regarding the changing of the City bank. The Credit Union is yet to respond.



1. 2. Robin Sines -Regarding complaint of sheep within city limits



An anonymous complaint was made regarding 5 sheep, 1 ram and 4 ewes (all possibly pregnant) weighing 60-100lb each, at 535 Spruce Street. According to Potlatch City Code section 9-3-11 Table 2-A Zoning Districts and Land Uses; grazing, livestock husbandry is not allowed in R1 single family residential areas. Livestock being defined in section 9-2-1 as "Hoofed domesticated animals, poultry, rabbits and fur bearing animals." Owner Robin Sines says the sheep are emotional support animals and help her daughter feel calm. She has tried bonding with other animals without success but found sheep to be a good fit as an emotional support animal. Robin furnished a signed letter from her daughter's counselor regarding the use of the sheep as emotional support animals. She also brought a petition her daughter's created signed by 30 neighbors. Robin is asking for an exemption to the city ordinance so her daughter may keep her emotional support animals. Donna Winther asked how clean is it for the neighbors and the school. Robin said she has had the animals for 2 years and no one has complained. She gives away the waste as fertilizer and is selling the wool and lambs for her daughter's college fund. Joan Bender asked how big the lot is. Robin said it is 1 acre, enough room for pets, however the sheep are in the side yard in a space the length of the house and 20ft wide and they have a 10'x8' shelter. Joan expressed concern that there have been past problems with hooved animals in the city, but each person treats their animals differently. Donna stated that there needs to be clean living conditions and enough room for the animals. Mayor Brown stated all the animals have been registered as service animals. David Cada said he was concerned about the precedent this sets when others have been denied and that he would like to say go ahead but can't due to what is in the ordinances and not wanting to be accused of favoritism. Martin Anderson suggested changing the ordinance to make it case based for service animals. All council members agreed that the space did not seem appropriate for 5 sheep. Robin stated that they were willing to go as low as one but one sheep would be lonely as they are herd animals and getting rid of all of them would send her daughter into a "tail spin."

Donna Winther made a motion for 2 sheep, both to be licensed by the city with a yearly permit or fee and a re-evaluation in 6 months to ensure the sheep are being properly cared for, have sufficient space and the area is kept clean. Martin Anderson seconded the motion, the motion was approved with "all ayes".



3. POE ASPHALT PAVING NEW QUOTE TO INCLUDE CEDAR STREET

Mayor Brown introduced the new POE Asphalt paving quote for \$33,500 for Cedar Street from Highway 6 to 7th Street. This would be in addition to \$28,695 for Spruce Street from Highway 6 to Ponderosa. Martin Anderson noted that if we do both at the same time POE will reduce the total by \$2,000.

Martin Anderson made a motion to approve the POE paving project for both Spruce and Cedar streets, Joan Bender seconded the motion, the motion was approved with "all ayes".


4. APPROVAL OF DESIGNATED SIGNERS FOR LATAH CREDIT UNION



6. PRESENTATION PRESNELL GAGE FINANCIAL STATEMENTS FOR YEAR ENDED SEPTEMBER 30, 2020

Mayor Brown presented the council with the financial statements from Presnell Gage. Mayor Brown asked the council if they would like a representative from Presnell Gage to come and explain the report. The council all agreed they would prefer to read them on their own.

- 3. **Pool & Cemetery Donna Winther -** Donna said she and Mayor Brown met this morning with Skeltons at the pool for a bid. Skeltons does not do the product that Crocs Coatings uses so they would need to have a representative from another company come and teach them how to do it. He didn't know much about the product and didn't take any pictures while




here. He will write up a quote but Donna said she wasn't confident in Skeltons ability to do the work that is needed at the pool. Donna said the coating needs to be non-absorbent and non-skid. A clear coat with a sealant can be done and would last one year. Lots of clean up needs to be done prior to work on the floor including removal of the urinal, lockers and partitions. Joan Bender asked what the Crocs quote was. Donna said \$16,000. Mayor Brown said revenue from RV Park could be used for both pool and RV Park showers. Martin Anderson said WSU surplus had lockers for \$60 a set. Mayor Brown suggested boxing in the urinal as the floor around it is in bad repair. Partition could cost between \$300-\$500 per wall. Donna said the partition walls need to be easily cleanable and we need to find out the recommendations for cleaning the floors. - 7. Clerk Harmony Nowack No report.





- 5. **Streets Martin Anderson -** Martin said the road work is all set up for this summer. Also the new development on the south east end of town is looking into easements. Mayor Brown asked if the city crew could cut out potholes in the city and have POE fill them.

2. DANIEL ANDERSON, TINY HOMES AT RIVERVIEW MANUFACTURED HOME COMMUNITY



shame to cut them down, what else could be done to keep the sidewalks from needing constant repair due to roots?

4. BMX track at Scenic 6 Park

Max Lusco has asked permission to create and maintain a BMX track at Scenic 6 Park. He will provide the dirt and create the track. The track would be just west of the RV Park on city property. Mayor Brown would like to have a fence put up between the two gates on Mill Road to direct traffic to city property as some of the land west of Scenic 6 belongs to the Potlatch Deltic Corp.

3. CITY BUY BACK PLAN



Fatbeam will be running fiber to the school district in Potlatch this summer and within the next year will likely be able to provide fiber to the residents of Potlatch. The fiber lines will be overhead on the existing Avista polls.

3. **Pool & Cemetery – Donna Winther –** The pool was able to open on June 10th. New sinks, toilets, flooring and dividers have all been installed. Pool staff said the new floors have been a bit slippery where water pools. Donna called Crocs Coatings, they are looking into a product they can put down to make the floor more gritty and should have an answer to Donna and the city by the end of the week. The health department came out to inspect the floors and approved. Next step for the pool is painting the outside of the building. Council asked if it might be possible to commission a mural? Donna will look into grant money that might be available for the pool as the pool needs a new liner and the pump and heaters could use an upgrade. The new filters are doing fine.



- 4. **Water & Sewer David Cada -** Dave Cada gave his report on the water in our area. He said that by the end of May we were on track weather wise for an average year, now with the current weather we have been experiencing this June we are on track for a wetter than normal year. Even though the hot summer we had last year didn't affect the Aquaphor the rain we have been getting this year is certainly recharging the Aquaphor.
- 5. **Streets Martin Anderson -** Paving was done on Cedar Street between 6th & 7th streets, Spruce street from 6th to the elementary school and on Cedar between 3rd to 4th street where the potholes were very bad.
- 6. **Scenic 6 David Cada** Scenic 6 meeting will be this Wednesday morning.
- 7. **Clerk Harmony Nowack –** Children Pedestrian Safety Grant was submitted last week. If accepted the grant would be used to put sidewalks in on 10th street. Council was informed that the Jake Brake Ordinance will be back on the next council agenda.

PUBLIC COMMENT:

Kass Meissner came to meet with City Council tonight on behalf of herself and her neighbors near 335 Spruce Street. She and her neighbors have concerns regarding new construction on the other side of the ally behind their respective houses. They feel as though the neighbors didn't get a chance to know what was happening or comment on the new residential construction. The neighborhood is in the historic Nob Hill section of Potlatch and Kass and many in the area are trying to restore the neighborhood to it's historical use. Mayor Brown said the owner of the property has gone thru all the correct processes with Planning and Zoning as well as the County. Kass said she would like to protect the neighborhood from high density housing. She said the historical value is in the 10 year plan and she would like the Council to make recommendations to preserve the historical aspects of the town before allowing development of very small properties. Mayor Brown said the city is working on updating codes for subdivisions and the like and also that there are state rules regarding updating historical buildings if they are on the historical register.

Sharon Montgomery at 630 Spruce had it approved by the city 6 years ago to plant two small maple trees in front of her house on the strip between the sidewalk and the street. This last Friday city summer crew came and trimmed the trees and left the branches on the ground. Sharon said the branches on this




particular maple grow up, not out and were not growing over the sidewalk. The pruning was not done properly as evidenced by the branches she brought in. She also stated large stubs were left behind on the tree. Sharon said the tree trunks are less than 10" in diameter and the trees were not in need of trimming. 

2. SENIOR CENTER IMPROVEMENTS




Diana Beard asked for the City's support in improving the front and back entrances to the Senior Center (formally the Rebekah Hall) including the ramp in the front and both entrance doors that have a lip that makes it hard for walkers to get over. The entrances need to be ADA approved. The Senior Citizen's group is requesting the city take on the project then bill the Senior Citizen's group up to \$10,000 as they are looking into a reimbursement grant for that amount. Lois Rasmussen commented that the building is used for many things other than the Senior Meals including elections. Donna Winther asked if the entrances/ramps need to be concrete or if a deck could be built with material like trex deck with an aluminum ramp. Martin Anderson said that could be done but the concrete needs to be replaced as the rock salt used in the winter has really eaten up the concrete. Lois commented that the current steps are quite high and deep for most people. Mayor Brown said trex deck could be built around the current stairs. David Cada asked how many people they have attend the Senior Meals. Lois said about 20 or so enough to fill 3-4 tables, more on Fridays when they have entertainment. They no longer do "grab & go" meals as covid restrictions have changed and they want people to come in and socialize. They do deliver some meals though. Lois said they need a drawing and a plan so they know what to ask for with the grant. Mayor Brown said the council would make a trip over to the Senior Center to take a look and also the city could look into smaller grants for ADA improvements or gem grants that are quick to get and there is no match.

3. Scenic 6 Park Restrooms

Mayor Brown introduced Krista Baker from CEDA. Mayor Brown has been working with her and Tony from Commerce to get a bathroom for Scenic 6 Park to be placed near the Splash Pad and RC Track. 



- 6. **Scenic 6 David Cada** Gary Strong is resigning as chairman. David will talk about city beautification at the next Scenic 6 meeting.




4. SEWER DUMP LEASE AGREEMENT RATES

The City of Potlatch will need to have a cash match of \$16,000-\$20,000 which will come out of the RV Park Fund. City labor and donations can also be added as part of the match.
